Co-Chairs

David Dorr, MD, MS



Dr. Dorr earned his BA in Economics (with minors in Mathematics and Psychology) and his MD from Washington University in St. Louis. He then completed Internal Medicine residency at Oregon Health & Science University, and earned a Master's in Medical Informatics and Health Services Administration from the University of Utah.

Broadly, David's interests lie in complex care management, especially for older adults and other at-risk populations, coordination of care, collaborative care, chronic disease management, quality, and the requirements of clinical information systems to support these areas. From these interests, he has broadened into clinical information needs, Electronic Health Record (EHR) deployment and Health Information Exchange as a way to expand systems-based approaches to all of health care. Finally, David performs evaluations of care management and informatics initiatives using a variety of methodologies.

His current projects include dissemination, further innovation, and evaluation of the Care Management Plus project (funded by The John A. Hartford Foundation). He developed the Integrated Care Coordination Information System (ICCS), a population management system connected to multiple EHRs and other data sources that does risk stratification, complex care management, quality measurement, and reporting. He works on primary care redesign modeling, using pragmatic/effectiveness trial designs to study how changes in incentives, technology infrastructure, and practice facilitation can help improve health, reduce cost, and improve patient satisfaction with care; his current study is the TOPMED trial (www.topmedtrial.org, funded by the Gordon and Betty Moore Foundation) and he provides technical assistance for the Comprehensive Primary Care initiative (<http://innovation.cms.gov/initiatives/Comprehensive-Primary-Care-Initiative/>)and informatics initiatives.

Rob Schreiber, MD



Rob Schreiber, M.D., CMD is Medical Director of Evidence based Programs at Hebrew SeniorLife and Medical Director of the Healthy Living Center of Excellence, an organization funded by the John A. Hartford Foundation and the Tufts Health Plan Foundation. The purpose of this collaborative is to disseminate evidence based programs throughout the Commonwealth of Massachusetts with the goal of building a sustainable business model. Dr. Schreiber is also working as a geriatric consultant in a Patient Centered Medical Home for an Accountable Care Organization and is helping the organization develop a population based approach to the frail complex older patient.

He served as Physician-in-Chief and CMO of Hebrew SeniorLife in Boston MA from 2004 to 2012 and provided oversight of the Hebrew SeniorLife Medical Group, which offers primary and specialty care services to older adults. He is also involved in promoting new initiatives, including new models of care at HSL's long-term care facilities, continuing care retirement communities, and senior housing sites Prior to joining HSL, Dr. Schreiber served as chairman of geriatrics at Lahey Clinic and held leadership positions at several Boston area long-term care facilities.

In his current role, he is a faculty member of the Institute for Aging Research at Hebrew SeniorLife and is working to connect research to health care systems clinical venues. He serves on the faculty at Harvard Medical School. Dr. Schreiber's interests focus on prevention and wellness strategies for older adults in ambulatory settings and post acute care in the community. He has been actively engaged in developing new models and approaches of care for older adults in various clinical settings. He is a Senior Leader of the Practice Change Leaders Program which mentors physicians, nurses and social workers improve the care of older adults in their health systems.

Christine (Himes) Fordyce, MD



Dr. Fordyce has been a geriatric primary care physician at Group Health in Washington state since 1988 where she has served in numerous leadership roles including Director of Geriatrics and Long Term Care, Medicare Medical Director, and Healthy Aging Medical Director. In the last 6 years she has led the work of integrating care systems for older adults into the PCMH for both the Group Health Physicians' group practice and network ACO's.

Currently, she is focused on the design and implementation of an evidence-based, full spectrum Preventive Care Model for Healthy Aging. This work is developing the frontline content for: 1) consumer engagement and self-management strategies in partnership with the consumer governed GH Board's Senior Caucus; 2) decision support for fundamental geriatric care best practices with education for provider teams and integration into the electronic medical record; 3) community partnerships; and, 4) public policy initiatives.

He is board certified in Family Medicine, has a Certificate of Added Qualifications in Geriatrics, and a Certificate in Medical Management from the American College of Physician Executives and Tulane University. He finished his Master’s degree in Medical Management at Tulane University

Dr. Strothers started practice at a rural National Health Service Corps site in South Carolina. He and his team implemented the MSM’s first Electronic Health Record in 2001 and one of the first 25 Georgia PCMH practices in 2012.
